Minutes of Previous Meeting

1. Matters Arising

- a. Stewards' contracts waiting to be signed once EPC and electrical safety tests were updated. The EPC and electrical safety checks were actually up to date.

2. **Secretary**

Draft copies of contracts for the stewards' cottage and bar and catering agreements had been circulated prior to the meeting. Members were requested to read and provide feedback on the contracts.

3. Finance

- a. Report at page 6.
- b. The junior fundraiser had been a success with £729 in cash raised on the day, entry fees of £500 and other receipts resulting in a £1400 half and half split between the junior section and Ashgate Hospice.
- c. Recovery of debts from Peak Hospitality was in the hands of an enforcement agency. Peak Hospitality had agreed to repay its debts in instalments.
- d. An offer had been made, by someone who preferred to remain anonymous, to provide an interest free loan to finance the par 5 project. Discussion had taken place in the past to explore the possibility of donations to the cause, and it was agreed that such a request should still be considered.

While this idea would still be looked at there was already one on order from a rental company, which would entail no maintenance from the club and would be replaced every two years or if deployed during a medical emergency.
- b. The lack of serviceable showers in the Men's changing rooms was considered to be unsatisfactory, especially when hosting visitors. The cost had been a delaying factor, especially since the post Covid period when the use of communal showers had fallen out of favour. The possibility of a wet room set up was discussed and with a club member being a supplier of wet room materials he would be approached to investigate potential supply and fitting costs.

BAKEWELL GOLF CLUB GREENS CHAIRMAN REPORT



JUNE 2025

Staff

- Unfortunately, the assistant greenkeeper, Alan Porter, who started last month didn't last. This was due to a combination of travel and conditions for staying overnight at the club in his campervan.
- Jack and I advertised for a new assistant for which we received interest from a couple of greenkeepers and some inexperienced candidates.

We interviewed Paul Rowlatt who has significant experience including being senior greenkeeper at Staverton Park, assistant greenkeeper at De Vere Selsdon, a course labourer at Colonial Country Club in Texas where he worked during the 1994 PGA Tour Colonial Classic and a course labourer at Banff Spring in Alberta, Canada. Jack and I were extremely impressed with Paul's knowledge and after receiving positive references from two previous employers we offered him the role of assistant greenkeeper which he has accepted.

Paul currently lives in Ripon where he was working as senior greenkeeper at Ripon City GC until it closed last year due to the hotel changing ownership.

We are hoping that Paul will be able to start in the coming weeks once he arranges accommodation.

Course General

- I am getting concerned about the vegetation encroaching from the field adjacent to the 1st hole and the
 potential for the fence to become damaged.
- Tree work has been caried out on the 2nd hole where some trees were becoming strangled by Ivy and the tree
 surgeon suggested that while he was removing two which concerned me it would be advisable to remove some
 additional trees which could become dangerous.
 - Removing these trees has made a significant improvement to the hole and opened up the stream area.
- The trees around the 8th/17th tees have been tidied and chipped.
- The large fallen tree on the right of the 4th hole has been removed and chipped. There is a lot of wild
 rose/hawthorn in this area which needs trimming back with a flail mower. We will contact Mick Burnet to price
 this for us unless we purchase a flail mower for the Par 5 project.

Irrigation System

The irrigation tank has been repaired and is now fully working.

No guarantee can be given by North Staffs irrigation as to how long the liner will last due to potential issues with the concrete base. They have advised that it should last at least a couple of years.

A plan should be put in place for replacing the tank/base in the future so we don't have a similar issues. I am currently consulting with a drilling company about the potential of a borehole for water abstraction.

Unfortunately, the irrigation system does not work on the 4th/13th tees. Over the years it looks like the sprinkler on the 13th tee has been neglected and buried which has more than likely caused the collapse of the tee. When the tee was renovated earlier this year we were unable to find any pipework. We will be able to manage the water on the tees in the short term with a hose pipe but North Staffs will need to reinstate the pipework and fix the issue – currently awaiting a quote.

The rest of the system and all sprinklers have been checked and I have also mapped all locations which will be plotted on an aerial photo so we have an accurate irrigation layout.

Greens

 The greens have been scarified and the mower has now been lowered to 4mm. We have seen a big improvement in the condition of the greens over the past couple of weeks. A huge thank you must go to Jack for the effort he has put in to keeping the greens playable while the
irrigation system has been out of action.

Tees

- The tees are starting to show improvement in growth. I have ordered 20 tonnes of rootzone to be delivered
 week commencing 16 June and we are hoping to top dress the tees to try and improve them.
- Members should be encouraged to use the sand/seed boxes to replace divots.

Equipment

• Unfortunately, we have had another breakdown to the Toro semi mower which meant the semi wasn't mown for around 10 days. The was extremely frustrating because it coincided with the Derbyshire Aggregates society and feedback was that the conditions were extremely difficult.
We have had various trials/demos of machinery to replace the semi mower. Jack and I would encourage the committee to consider the purchase of a Major tractor mounted mowing unit. This mower would allow for different heights of semi/rough to be mown and should be much more reliable than the current machine which is extremely temperamental.

Health & Safety

- We continue to struggle with the spreader and sprayer attachments for the gator. These two items require
 manually lifting on and off the gator whenever they are required and are extremely heavy and dangerous.
 Furthermore, once the spreader if attached, soil and/or sand needs to be shovelled over head height to fill
 the spreader.
 - It takes around 40 minutes for two/three people to change the units which need to be balanced on wooden pallets once removed.
 - We are actively looking to sell the gator and attachments to raise funds for purchasing more suitable items.
- We are finding more dog dirt on the course which is unacceptable. Jack has found bagged waste left at the side of the practice bay and I saw significant amounts on the 9th hole while I was mowing the semi.
